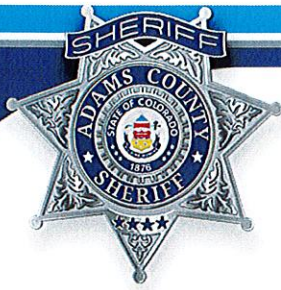

LIABILITY WAIVER

1. I am participating in the Adams County Sheriff's Office Summer Teen Academy (hereafter referred to as the "Teen Academy"). My participation in the Teen Academy may include but is not limited to demonstrations on firearms, the driving track, self-defensive tactics, the crime lab and K-9 unit. These activities involve risks and hazards to my physical safety. I recognize serious and potentially life-threatening injuries can occur while participating in these activities whether in a structured program, personal participation or by simply being present while others engage in the activities.
2. I understand that it is my responsibility to consult with a physician prior to and regarding my participation in these activities. I am physically fit and I have no medical, psychological, or other condition which would prevent my full participation in all of the activities during the Teen Academy.
3. I am not prohibited from possessing or using a firearm or ammunition for any reason including but not limited to felony conviction(s), domestic violence restraining order, or civil protection order. I am legally free to own, possess or handle firearms and ammunition. (Applies to students who are 18 years old)
4. I understand that I must obey any instruction or direction given by members of the Teen Academy staff. Failure to abide by any instruction may result in the immediate termination of my participation from the Teen Academy.
5. In consideration of being permitted to participate in the Teen Academy, I agree to assume full responsibility for all risks, injuries, or damages, known or unknown of whatsoever kind and nature, which I might incur as a result of participating in the Teen Academy.
6. In further consideration of being permitted to participate in the Teen Academy, I knowingly, voluntarily and expressly waive any and all claims completely and without reservation, I, or my Estate, my heirs or any person claiming under me, may have against Adams County, the Adams County Sheriff's Office, its agents, employees, instructors, volunteers, or representatives from any and all injuries or damages that I may sustain as a result of participating in the Teen Academy. Monday June 5th through Friday June 9th, 2023 from 8:00am-2:00pm, at the Adams County Sheriff's Office Substation located at 4201 E. 72nd Avenue, Commerce City, CO 80022.

Designed specifically for 8th grade and high school students, this five-day academy will give you an inside look at the day to day operations of the Adams County Sheriff's Office.

You will have the unique opportunity to learn about several topics such as:

- SWAT
- Self Defense / Police Communications / Drug and Alcohol Education
- K-9's
- Building Searches / Criminal Law
- Crime Scene Investigations, including a practical day where you process evidence
- Emergency Vehicle Operation

All classes are instructed by Adams County Sheriff's Office Deputies.

Attendance of all five days is a requirement for successful graduation from the academy.

To participate:

- You must be 13 – 18 years old and currently in 8th-12th grade
- Maintain at least a 2.0 GPA or higher
- Be a high school student currently attending school in, or living in, Unincorporated Adams County.
- Pass a background check

Applications will be processed in the order in which they are received.

The cost to attend is **FREE**.

Each participant will receive a Teen Academy T-Shirt, graduation certificate and reference materials.

To register, complete an application. See your School Resource Officer or main office for additional information.

All interested students will be contacted prior to the Academy with specifics about their participation.

ADAMS COUNTY SHERIFF'S OFFICE TEEN ACADEMY CODE OF CONDUCT

PURPOSE

The Adams County Sheriff's Office Teen Academy is modeled after the Citizens' Police Academy and is designed to give young people the opportunity to learn about the Adams County Sheriff's Office and its day to day operations. This program supports our Mission to further promote positive relationships between the community and deputies to demonstrate the benefits of law enforcement and community partnerships in our county. It also gives the Sheriff's Office an opportunity to interact with youth and solicit their feedback and ideas through discussion of issues currently impacting the county. It is the hope of the Adams County Sheriff's Office, through this thirty-six-hour academy, to provide students with knowledge and understanding of the functions and responsibilities of providing law enforcement services in Adams County.

ACADEMY

The Academy will be directed by personnel from the Juvenile Services Unit and other personnel from throughout the Agency and will cover topics including basic law enforcement, Crime Scene Investigation, background on each of the department's specialized units such as SWAT, K-9, and others.

ELIGIBILITY REQUIREMENTS

- Be 13 to 18 years of age and currently in 8th-12th grade
- Enrolled and attending school having a 2.0 GPA or higher
- Have a parent's written consent to attend
- Must attend all 40 hours to graduate
- Complete and pass a background investigation
- Provide a sports physical form
- **Apply by May 1st, 2023 at 5:00pm.**

ATTENDANCE

Due to the program's length, an absence from any class is not allowed for graduation and there will be no "make-up" classes. Punctuality is essential. Please arrive 15 minutes prior to the beginning of class. Parents will not be allowed to participate with their students.

TRANSPORTATION

Students will report to the Adams County Substation each morning at 7:45am. Students will be dismissed from the Adams County Substation each day at 2:00pm. If you are a student in Bennett or Strasburg, please contact your SRO for further transportation instructions. Transportation will be provided to and from the Substation when classes are held at different locations, such as the FLATROCK Regional Training Center located and 23600 E. 128th

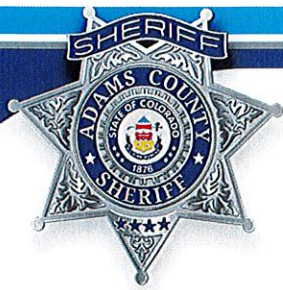

ADAMS COUNTY SHERIFF'S OFFICE TEEN ACADEMY CODE OF CONDUCT

1. Students are required to obey all orders of the academy staff, and entrance into restricted areas without the explicit consent of an instructor is forbidden.
2. Students are required to participate in all classroom / lab assignments and will not be excused from any activity without permission.
3. Should a student become injured or sick during the academy they must report the incident to the instructor or coordinator immediately.
4. Students will refrain from obscene, vulgar or profane language at all times.
5. Students will conduct themselves in a professional manner and respect the instructors and other students in the class. In the event a participant's conduct is disruptive to the class or violates the rules, the individual may be terminated from the program. Respect for others is mandatory.
6. The academy will operate under a quasi-military atmosphere with a wide variety of class instruction and interaction to include hands-on training.
7. Pictures of crime scenes will be displayed. Prior notice of content will be given and students will have the option of not attending those portions of the academy class.

DRESS CODE

The academy has been developed to give each student the best possible learning experience. Therefore, it is necessary that dress and personal hygiene be followed by each of the class members. **Students will be required to wear issued Academy Shirt and closed toe shoes throughout the academy.**

CODE OF CONDUCT CONTRACT

The purpose of this contract is to inform the student that they must comply with all provisions of the Adams County Sheriff's Office Teen Academy and to the specific terms set forth herein. The student understands that due to the nature of this academy there will be a zero tolerance rule in effect. Undesirable conduct such as horseplay or a violation of the conduct code will result in the immediate removal of the student from the academy. This contract is in effect for the safety of all students and instructors. This contract represents an agreement by the student that they received a copy of the Code of Conduct and the student agrees to adhere to this Code of Conduct at all times while enrolled in the Adams County Sheriff's Office Teen Academy.
