*30-1-108 All officers of this state who are required to collect fees for their services are required to make fair tables of the respective fees and keep the same posted in their respective offices in some conspicuous place, for the inspection of all persons who shall have business in such office - penalty \$5 per day for each day not posted.

*<u>30-1-116</u> Every officer shall collect every fee, as prescribed, for services performed by him in advance, if the same can be ascertained, and when any officer negligently or willfully fails to collect any such fee, the same shall be charged against his salary.
