Retiree Concealed Handgun Permits  
RANGE QUALIFICATION**



The Adams County Sheriff's Office procedure for compliance with the Federal Concealed Carry Permit Legislation Pursuant to Chapter 44 of Title 18, United States Code, § 926C, the 'Law Enforcement Officer Safety Act of 2004', also known as HR 218 is in place. This law has been revised and updated in 2013. See <http://le.nra.org/leosa.aspx> for additional information.

**Beginning on Monday, April 02, 2007, and on every first Monday of every month thereafter**, the Adams County Sheriff's Office will accommodate retired Law Enforcement personnel needing to qualify with a firearm, as specified in *Colorado P.O.S.T. Rule 27- Retired Law Enforcement Officer Authority to Carry Concealed Firearms Revised December 08, 2006-Effective March 01, 2007.*

**On the first Monday of every month**, the Adams County Sheriff's Office **Flat Rock Training Facility, located at 23600 E 128<sup>th</sup> Avenue, Brighton CO (east of Picadilly Rd on E 128th Ave)**, will accommodate retired Law Enforcement Officers needing to qualify with a firearm, as specified in Colorado P.O.S.T. Rule 27 - Retired Law Enforcement Officer Authority to Carry Concealed Firearms Revised December 8, 2006 - Effective March 1, 2007. The time is **10:00 A.M. sharp.**

Those wishing to qualify must be residents of Colorado, and meet the criteria specified in the above listed P.O.S.T. Rule 27. Retirees should contact Flat Rock range staff at **720-523-7501** to confirm space and time at the range. You must bring at least 20 rounds of factory ammunition. No reloads or non-standard ammunition will be allowed on the range. Your weapon and ammunition will be inspected for safety before being allowed on the range. The qualification course will be as determined by Range Staff. More information about the shooting course can be requested by calling the training facility staff at the above number.
